## NEW BUSINESS

## Changes to By-Laws

Article 1 Section 2e - Warren Biss suggested that the by-laws be amended to integrate Antitrust concerns to accommodate international clubs.

- It was suggested to change the wording to say "As per your country,..."
- No second was made, adopted by consensus

Article 2 Section 5a - Warren Biss suggested that the statement about the 99999 pin be removed.

- The board discussed that it be kept so that its location is documented.


## Article 2 Section 6 - Life Memberships were discussed.

- A change was not suggested except that it needs consistent terminology.
- If a club goes inactive, is the life member still a life member? Who pays dues?
- Need to change by-laws to include what the protocol is
- They become a member-at-large and pay their own dues
- How is it supposed to show up on the Remittance list?
- A Life member says \$0
- Need an "L" beside their name
- What does their invoice look like?
- Clubs keep up with life members and pay their dues, as check to HHI
- No specific motion was made, no seconds, nothing passed

Article 4 Section 1(a) - Warren Biss suggested that we change " 39 " days to " 99 " days.

- Jack Miller suggested instead of changing the day, add "unless approved by the board".
- Warren will send to Ron Gattone to clean up the wording
- No second was made, no substitute motion was made, nothing passed
- Need to refer the motion to an appropriate committee with instructions to report back

Article 6 Section 1 - Warren Biss suggested we not make the meeting during Forest Festival mandatory for the Board.

- Delete "October"
- Instead of "shall" change to "may" to read "Other meetings may be in such a place and such a time as the Snark may designate."
- No substitute motion was made, no second was made, nothing passed

Article 6 Section 2 - Warren Biss suggested changing the 14 day timeframe.

- Change "14 days" to "72 hours"
- No second was made, all agreed, adopt by consensus (if possible)

Article 15 Section 3 - Warren Biss suggested that the Secretary/Treasurer be given permission to also hold a concatenation.

- Add "International Board" to read, "The Snark of the Universe, Rameses, any member of the Supreme Nine, and any member of the International Board, may hold concatenations..."
- No substitute motion was made, no seconds, all agreed, adopt by consensus (if possible)

Article 17(b) - Warren Biss suggested that the minimum number of members change.

- Drop the minimum of "nine".
- No final decision was discussed on what the final wording should be
- No specific/substitute motion was made, no seconds, nothing passed

During discussion, the following topics were interjected...

- It was suggested that the Mid-Year meeting be held in Gurdon every year.
- Nowhere in the by-laws is the Mid-Year meeting mentioned.

- Executive Secretary was nominated to take over publishing of Log \& Tally, in the future, for $\$ 600$ per issue, the same as Joy.
- Robyn Young motioned, Paul Beltgens seconded, adopt by consensus, motion passed
